Before a request is made for information, it may be helpful to see if the information required is already available on the Little Eaton Parish Council website. For instance, Parish Council decisions, spend and planning responses can be found in the council's minutes.

Please note that Little Eaton Parish Council's information is available unless:

- it does not hold the information;
- the information is exempt under one of the Freedom of Information Act exemptions or Environmental Information Regulations exceptions, or its release is prohibited by another statute;
- the information is readily and publicly available from an external website; such information may have been provided by the public authority or on its behalf.
- the information is archived, out of date or otherwise inaccessible; or,
- it would be impractical or resource-intensive to prepare the material for routine release.
